Wrapping Up Open Enrollment

Thank you to everyone who submitted their 2023 Open Enrollment Form online. Congratulations to those employees who completed the Health Risk Assessment and are now eligible to receive the \$100/month Health Savings Account contribution from CCLS in 2023! As we go into the new payroll calendar year, please be sure to double check the deductions on your 1/13/23 pay stub to make sure they match your elections for 2023.



Please remember your elections are in effect for the entire calendar year of 2023 unless you have a change in status known as a qualifying event. These include changes in marital status, increase or decrease in # of dependents, change in employment status and more. These events create a special enrollment window where you can make changes to your elections which are consistent with the qualifying event.

Lastly, for those enrolled in health, remember to check your QuartzWell portal and email yourself any Amazon Reward Codes you earned in 2022. The portal resets on 12/31/22. While you are in there, check out the resources Quartz offers such as Health Coaching and Health Management Programs. If you make any New Year's Resolutions, they'll be a great help. 
How to use AmazonSmile using the Amazon app on your mobile phone:

All Wisconsin households can order a free package of COVID-19 self-tests each month

The Wisconsin Department of Health Services (DHS) is encouraging Wisconsinites to order free at-home rapid COVID-19 tests and have them delivered directly to their house through the state-

supported Say Yes! COVID Test program. Starting today, all Wisconsin households are eligible to place an order every month for one free test kit that contains five rapid antigen COVID-19 tests on the <u>Say Yes! COVID Test</u> website.

"With the holidays coming up, we want to give Wisconsinites the tools they need to safely celebrate with their loved ones," said DHS Secretary-designee Karen Timberlake. "These free self-tests are delivered right to the door, allowing people to take a COVID-19 test at home and make decisions that will keep those around them safe."
